## **SCHEDULE 1**

### **VOTING ENTITLEMENT:**

Class and Category of membership and Vote entitlement:

1. Full Membership Class:

- Categorized as:
  - Parkour Parks
  - Parkour Academies
  - Team
  - Professional Athlete
- Entitled to one (1) National vote and;
- Entitled to one (1) Provincial vote.
- Pay subscription fees in accordance with Article 29.

2. Affiliate membership Class:

- Categorized as:
  - Individual practitioners
  - Teams
- Not entitled to a national vote
- Entitled to one (1) provincial vote
- Do not pay subscription fees in accordance with Article 29.

## **SCHEDULE 2**

### **TRANSITIONAL ARRANGEMENTS**

1. The Board will:
  - 1.1. issue as at the date of incorporation and adoption of these Articles and thereafter advertise from time to time a list of any vacancies arising from the composition of the Board under Article 9; and
  - 1.2. endeavour to fill such vacancies as soon as reasonably practicable in accordance with these Articles
2. In order to be compliant with Article 9, the following transitional arrangements shall be implemented with effect from the date of incorporation and adoption of these Articles:
3. The Founding members appoint a transitional Board consisting of
  - 3.1. Three (3) Elected Directors
  - 3.2. One (1) Independent Directors
  - 3.3. A Chief Executive
4. The transitional Board shall organise the first AGM to be held within 210 days of incorporation
5. The Transitional Board shall remain in office as follows:
  - 5.1. Elected Director 1 – must retire and be eligible for re-nomination at the 2015 AGM
  - 5.2. Elected Director 2 - must retire and be eligible for re-nomination at the 2016 AGM
  - 5.3. Elected Director 3 - must retire and be eligible for re-nomination at the 2017 AGM
  - 5.4. Elected Director 4 - must retire and be eligible for re-nomination at the 2018 AGM
  - 5.5. Independent Director 1 - must retire and be eligible for re-appointment at the 2018 AGM
  - 5.6. The Chief Executive - must be re-nominated for appointment at the 2018 AGM




### FOUNDING AGREEMENT

## **Schedule 4:**

### **Parkour South Africa Membership Application**
